**Membership Mandate**

**1. Parties to the Agreement**

This Mandate and Deed of Assignment (Agreement) is made on the [Date]..... at [Location].....between:

(Hereinafter referred to as the “Assignor,” which term shall include the Assignor’s heirs, executors, administrators, and assigns.)

**(b) The Assignee**  
Authors, Composers and Publishers Organization of Sri Lanka (“ACPOSL”), a company incorporated under the Companies Act No. 07 of 2007, Registration No. GA 00309423, with its registered office at Nawaloka Building, No. 115, Sir James Peiris Mawatha, Colombo 02. (Hereinafter referred to as the “Assignee,” which term shall include its successors and permitted assigns.)

## 2. Definitions

For the purpose of this Agreement:

- **“Public Performance Rights”** means the right to perform musical works in public, whether live, broadcast, or digital.
- **“Digital Rights”** means digital performance and mechanical reproduction rights, excluding synchronization rights unless expressly mandated in writing.
- **“Territory”** means the Republic of Sri Lanka unless expressly extended in writing.
- **“Works”** means all musical works owned, controlled, or created by the Member, including music and lyrics.

## 3. Grant of Rights – Public Performance (Mandatory)

The Assignor hereby grants ACPOSL the exclusive right to administer, license, and collect royalties for the public performance of the Assignor’s musical works within the Territory, for the duration of this Agreement, subject to reciprocal agreements with foreign collective management organisations. This includes:

- a. Live performances;
- b. Radio, television, and other broadcast performances;
- c. Digital streaming and online transmissions.

## 4. Grant of Rights – Digital Licensing (Optional Opt-In)

Where elected by the Assignor or authorized Publisher, ACPOSL shall have the right to license and collect royalties for the following in the Territory:

- 4.1 **Digital Performance Rights** – streaming, simulcasting, webcasting, and any other form of digital performance.
- 4.2 **Digital Mechanical Rights** – reproduction, storage, caching, and downloading in digital formats.
- 4.3 **Other Digital Rights** – Synchronization rights for online platforms, where ACPOSL may act solely as a facilitating or administrative agent, subject to the express written approval of the copyright owner or publisher

Any such digital or mechanical rights, where administered, shall be accounted for separately and shall not form part of mandatory collective distributions under ACPOSL Distribution Rules

## **5. Partial Rights & Carve-Outs**

Where certain rights in Clause 4 have been granted to another party, ACPOSL's mandate applies only to the remaining rights unless authorized otherwise in writing.

## **6. Publisher Representation Agreements**

Where a Publisher controls certain rights in the Assignor's works, ACPOSL may contract directly with such Publisher to administer those rights in Sri Lanka, subject to:

- Limitation to Sri Lanka territory unless otherwise agreed;
- Inclusion of all relevant works controlled by the Publisher for the Member;
- Direct royalty collection from DSPs and other licensees. Provided that ACPOSL shall not grant synchronization licences or determine synchronization fees without express written authorization from the Publisher

## **7. Territorial Limitation**

Unless expressly agreed otherwise in writing, this mandate applies only to the Territory.

## **8. Non-Conflict with Existing Agreements**

This Agreement is subject to any exclusive grants made by the Assignor to third parties for the rights in Clause 4. ACPOSL will only exercise such rights with the consent of the controlling party.

## **9. Future Assignments**

If the Assignor assigns rights covered by Clause 4 after signing this Agreement, they shall ensure either:

- a. ACPOSL is authorized to continue administration in Sri Lanka; or
- b. ACPOSL is notified to contract directly with the new rights holder.

## **10. Warranties & Indemnities**

The Assignor warrants that they have full ownership and authority to grant the rights assigned, and that the works do not infringe the rights of any third party.

The Assignor shall indemnify ACPOSL against any claims, losses, or expenses arising from a breach of this warranty.

## **11. Collection & Distribution**

ACPOSL shall retain an administrative deduction in accordance with its Board-approved budgets and published tariff and distribution rules.

ACPOSL shall administer the assigned rights on a non-discriminatory basis and shall distribute royalties strictly in accordance with declared ownership shares and its approved distribution rules.

## **12. Reversion of Rights**

Upon termination, ACPOSL shall continue to administer and distribute royalties accrued prior to termination, including post-term distributions, in accordance with its distribution rules.

## **13. Term & Termination**

This Agreement remains in force until terminated by either party with **three (3) months' written notice**, subject to ACPOSL's right to collect royalties accrued prior to termination.

## **14. Notices**

The Assignor shall promptly notify ACPOSL in writing of any changes in contact details.

## **15. Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the Democratic Socialist Republic of Sri Lanka.
